Case Histories for the Meeting of Monday, January 9th, 2017

SB 6121 Peyman Samghabadi/Hannes Vogel; Stanford

Previously-health 6-year old female who presents with a several week history of head tilt and more recently history of balance difficulties, including a collision with a schoolmate with resultant loss of consciousness. She was taken to the ED where a head CT revealed a 3x4cm hypoechoic lesion in the left posterior fossa with mass effect on the pons. DDx includes primary cystic abnormalities such as arachnoid cyst and neoplastic lesions.

38-year-old man with 6.2x4.7x4.6cm chest wall tumor apparently arising from first left rib.

SB 6123 Sharon Wu/Roger Warnke; Stanford

64-year-old woman with supraclavicular lymphadenopathy.

DIAGNOSIS:

SB 6124 (scanned slide available) Mahendra Ranchod; Good Samaritan Hospital 62-year-old woman presented with 1 year history of abdominal pain. A cystic lesion (13cm in maximum dimension) was resected from right lobe of liver.

SB 6125 (scanned slide available) Keith Duncan; Mills-Peninsula Hospital 80-year-old woman with small bowel obstruction and 7.5cm firm tan tumor within mesenteric fat. History of prior upper quadrant tumor resection 2 years prior.

SB 6126 A&B (scanned slide available) Ankur Sangoi; El Camino Hospital 48-year-old male with testicular mass and mildly elevated AFP.

72-year-old male with bladder lesion biopsy.

SB 6128 (scanned slide available) Jenny Hoffman/Dean Fong; Stanford/Palo Alto VA

28-year-old man with history of acute pancreatitis, ESRD on HD, and severe pancytopenia. Family history significant for benign familial neutropenia. Bone marrow biopsy performed.

SB 6129 Jenny Hoffman/Richard Sibley/Robert Rouse/Robert Ohgami; Stanford 67-year-old man with mediastinal mass invading into pleural space.

SB 6130 Natalia Isaza; Kaiser Santa Clara

43-year-old woman with a history of AIS in 2008/2009, with negative or ASCUS Paps since. HPV noted to be positive in 2009 and 2013, but all other years have been negative. Colposcopy in February 2015 was benign. Most recently (February 2016) had a negative Pap, negative endocervical curettage, and negative HPV test. This Pap smear is taken in August 2016.
